

**Обґрунтування технічних та якісних характеристик предмета закупівлі,

Предмет закупівлі: *Харвестери (ДК 021:2015 код 34140000-0 Великовантажні мототранспортні засоби)*

Обґрунтування технічних та якісних характеристик предмета закупівлі.

Для забезпечення виробничих потреб ДП «Ліси України» та відповідно до Інвестиційного плану ДП «Ліси України» на 2025 рік виникла необхідність у закупівлі харвестерів (багатоопераційної лісозаготівельної машини для рубок формування та оздоровлення лісів). Технічні та якісні характеристики предмета закупівлі визначені на підставі наявної потреби, з урахуванням специфіки технологічних процесів підприємства. Визначені технічні та якісні характеристики предмета закупівлі є необхідними та достатніми (оптимальними) для задоволення потреб підприємства та відповідають наявним ринковим пропозиціям. Деталізовані технічні та якісні характеристики товару наведені у Технічній специфікації (Розділ VII) тендерної документації.

Розділ 2. Загальні вимоги до Товару

2.1. Товар має бути новим, таким, що не перебував до моменту відвантаження Покупцю в експлуатації (за виключенням передвідвантажувального тестування Товару), без механічних пошкоджень, слідів корозії тощо.

2.2. Товар має відповідати Регламенту Європейського Парламенту і Ради (ЄС) № 167/2013 від 5 лютого 2013 р. про затвердження сільськогосподарських і лісгосподарських транспортних засобів та ринкового нагляду щодо них.

2.3. Товар має бути доведений до стану, придатного для експлуатації на території Покупця. Детальні вимоги щодо доведення Товару до стану, придатного для експлуатації наведені в проекті Договору.

2.4. Товар, що є предметом закупівлі, повинен мати ступінь локалізації виробництва, що дорівнює чи перевищує 25 відсотків.*

**Зазначена вимога щодо ступеню локалізації не застосовується до товарів, країною походження яких є країна, яка є стороною Угоди про державні закупівлі, укладеної 15 квітня*

1994 р. в м. Марракеші, із змінами, внесеними Протоколом про внесення змін до Угоди про державні закупівлі, вчиненим 30 березня 2012 р. в м. Женеві, з якою Україна уклала інші міжнародні договори України, згода на обов'язковість яких надана Верховною Радою України, що містять положення про державні закупівлі, у тому числі угоди про вільну торгівлю, або країна, яка є учасником Угоди про державні закупівлі, до якої Україна приєдналася відповідно до Закону України "Про приєднання України до Угоди про державні закупівлі".

Розділ 3. Вимоги до постачання Товару

3.1. Умови поставки: FCA (Free Carrier) Incoterms 2020, склад Постачальника. Постачальник несе всі витрати на пакування, завантаження, монтажні матеріали для транспортування, транспортні витрати, витрати на отримання сертифікату походження Товару, податки та інші обов'язкові платежі, які оплачуються Постачальником при експорті Товару.

3.2. Поставка першої одиниці Товару має бути здійснена впродовж 90 календарних днів з моменту сплати першого авансового платежу. Поставка решти Товару (в кількості, вказаній в Замовленні Покупця) повинна бути здійснена протягом 90 (дев'яносто) календарних днів з моменту сплати першого авансового платежу на підставі поданого Замовлення Покупцем, яке оформляється після поставки першої одиниці.

3.3. Постачальник гарантує доступність запасних частин та комплектуючих виробів до Товару протягом принаймні 7 (семи) років з дати поставки кожної одиниці Товару.

У разі зняття запасних частин або комплектуючих виробів з виробництва протягом зазначеного строку Постачальник забезпечує їх заміну на сумісні аналоги, які відповідають технічним і функціональним характеристикам оригінальних компонентів, без погіршення їх експлуатаційних властивостей.

Обґрунтування очікуваної вартості предмета закупівлі.

На засіданні Комісії з питань інвестиційних проектів, діючої на підставі Наказу ДП «Ліси України» від 14.06.2023 №1187, було прийняте рішення щодо затвердження Інвестиційного плану ДП «Ліси України» на 2025 рік в розрізі інвестиційних проектів зазначених у додатках до затвердженого протоколу засідання Комісії з питань інвестиційних проектів від 23.01.2025 №12.

Відповідно до Положення про організацію публічних закупівель ДП «Ліси України», затвердженого наказом №580 від 18.03.2025 р., для визначення очікуваної вартості предмета закупівлі, було направлено 7 письмових запитів цінових пропозицій електронною поштою виробникам харвестерів.

У відповідь були отримані комерційні пропозиції від **Terri AB, Ponsse Oyj, UAB "Dojus agro", Vimek AB** щодо вартості харвестерів, враховуючи основні умови договору поставки.

Дані відображені нижче в Таблиці 1.

Цінові пропозиції для визначення очікуваної вартості предмета закупівлі у всіх випадках аналізуються (порівнюються) без урахування ПДВ.

Враховуючи вищенаведене, очікувана вартість визначена на рівні 1 355 000 євро без ПДВ.
